

## The Protection of Unborn Life Act



1. Be it enacted by this Congress here assembled that
2. **Section I:** All forms of pregnancy termination, with the exceptions of when pregnancy
3. and/or childbirth is being a threat of a mother's life, the woman is pregnant because of
4. rape, or the woman is pregnant because of incest, shall be banned in the United States
5. of America and any place subject to their jurisdiction.
6. **Section II:** Pregnancy termination shall be defined as when any fetus in a woman's
7. uterus, after conception, is killed or the fetus is removed from the womb before
8. the unborn baby's natural or cesarean birth or due date.
9. **Section III:** The Department of Justice will be responsible for the enforcement of this
10. bill. Violation of this bill will result in life incarceration. Any woman who voluntarily
11. receives a pregnancy termination service or anyone who voluntarily gives a pregnancy
12. termination service shall be considered in violation of this bill.
13. **Section IV:** This bill requires no funding.
14. **Section V:** This bill shall be implemented on January 1, 2020.
15. **Section VI:** All other laws and portions of laws in conflict with this bill shall hereby be
16. considered null and void.

## Catcall Ticketing Act

1. Be enacted by this congress here assembled that:
2. **Section I:** Catcalling being seen by a police officer should fine the assaulter.
3. Catcalling is defined as unwanted or unwarranted sexually suggestive comments
4. made from one person to another.
5. **Section II:** When a police officer sees a person getting catcalled, the officer
6. should evaluate the situation. If the victim states that these comments by the
7. assailant were unwanted, therefore the officer has the right to ticket the assailant.
8. The ticketing procedures will be the same as giving a person a speeding ticket.
9. The first time ticket for catcalling is fine for ninety dollars. The second time
10. Ticketed, within two years, for catcalling is fine or one hundred fifty-five
11. dollars. Three or more times
12. ticketed for catcalling is send to court to be punished determined by the court.
13. **Section III:** This bill will be enforced by local and state police departments.
14. Failure to comply with this bill will result in a fine \$400 for the first offense, and
15. double the amount for each time this bill is violated.
16. **Section IV:** All other laws conflicting with or pertaining to this law are now null
17. and void.
18. **Section V:** This legislation will be implemented on January 1, 2018.

## A Bill to Promote Effective Gun Control

1. Be it enacted by this here Congress that:
2. **Section I:** The Social Security Administration will be required to release information of
3. mentally ill recipients of social security benefits to be included in background checks.
4. **Section II:** The mentally ill shall be defined as those individuals who have a documented
5. mental health issue, receive disability benefits, and are unable to manage those benefits
6. because of their mental impairment, or who have been found by a state or federal court to
7. be legally incompetent. The information gained will be used solely in background checks
8. conducted by the National Instant Criminal Background Check System, NICS.
9. **Section III:** This bill will be implemented January 1st, 2018.
10. **Section IV:** This bill will be implemented by the Bureau of Tobacco, Alcohol, Firearms,  
and Explosives (ATF) and the Department of Justice. Any necessary funding will come  
from a 0.5% decrease in the defense budget.
11. **Section V:** All laws and portions of laws found to be in conflict with the provisions of  
this bill are hereby declared null and void.

## Bill to Implement American Sign Language into Curriculum Act

1. Be it enacted by this Congress here assembled that:
2. **Section I:** All public schools grade level 8 through 12 will implement the
3. ASL (American Sign Language) as an optional language elective.
4. **Section II:** ASL will be defined as the hand-signaled language deaf or hearing impaired
5. citizens use to communicate effectively. This bill will take place over a one year period
6. and will be implemented by placing new or existing teachers fluent in ASL into
7. classrooms. This bill will be integrated as a curriculum choice over two years. This will
8. enable teachers to become certified in sign language. Completion of this course will
9. count as a language requirement for graduation. After this bill is implemented, any school
10. who does not have a certified ASL teacher after six consecutive months will be given a
11. warning. At the end of the second year, any district not in compliance will be fined a
12. total of 50,000 dollars every year until they come into compliance.
13. **Section III:** This Legislation shall take effect at the beginning of the 2019-2020 school
14. year.
15. **Section IV:** The U.S. Department of Education will be responsible for the enforcement
16. of this bill. Additionally, funding for the enforcement of this bill will come from a 1% tax
17. on alcohol and a 1% tax on tobacco, as well as the collected fines from non-compliance.
18. **Section V:** Any and all bills contradicting this bill are hereby declared null and void.

**Bill to abolish the death penalty**

9. **Section IV:** Any previous laws conflicting with this bill shall hereby be declared null

10. and void

11. **Section V:** This bill need no additional funding to be put into effect.

12. **Section VI:** This bill shall be put into effect January 1st, 2020.

### **The Decreased Military Spending Act**

1. Be it enacted by this Congress here assembled that:
2. **Section 1:** Discretionary spending on the military will decrease by 20 percent from
3. its current amount.
4. **Section II:** This decrease will take place over the course of 20 years. Each year, the
5. budget of the military will decrease by 1 percent of the current military budget.
6. **Section III:** This legislation shall take effect on January 1st, 2023, meaning that the
7. decrease in spending will take effect for the first time in the year 2023.
8. **Section IV:** The Department of Defense will be responsible for the enforcement of this
9. Bill. Each year, the Defense Department will send Congress a breakdown of what
10. programs will be eliminated or will receive a smaller amount of funding. If Congress
11. does not agree with Defense Department's proposed budget, Congress can create a
12. budget for the Defense Department that still takes the decreased military budget into
13. account. In order for Congress's budget proposal to override that of the Defense
14. Department, Congress must pass its proposal in both houses and have the proposal signed
15. by the president. Otherwise, the Defense Department's budget proposal will take effect.
16. **Section V:** All laws or portions of laws in conflict with the provisions of this legislation
17. shall hereby be declared null and void.

## Refugees Welcome Bill



1. *Be it enacted by the Congress here that:*
2. **Section I** The number of refugees accepted into the United States will increase from 70,000
3. to 250,000 refugees the first year then by 50,000 for five years after that.
4. **Section II** A Refugee shall be defined as someone who has been forced to flee his or her own
5. country because of persecution, war, or violence. Persecution shall be defined as fear for
6. reasons of race, religion, nationality, political opinion or membership in a particular social group.
7. **Section III** The Refugee Affairs Division at the U.S. Citizenship and Immigration Services shall
8. assume responsibility and conduct security checks of applicants, health examinations, and a
9. review of applications. All necessary funding for this bill shall be provided by a 3 percent tax
10. increase on tobacco.
11. **Section IV** All other laws or portions conflicting with or pertaining to this law shall
12. hereby be declared null and void
13. **Section V** This bill shall be implemented on January 21st, 2019.

## A Bill To Convert The US Measuring System To Metric

1. Be it enacted by this congress here assembled that
2. **Section I:** The US converts its official system of measurements from the current United States Customary
- 3 System to 3 the internationally used Metric System
4. **Section II** Our measurements shall all be in metric units via a gradual process of 10 years
5. **Section III:** All new infrastructure projects on roads shall immediately use the metric system, and slowly,
6. road signs will be in kilometres and kilograms highway by highway until 2027, when all public signs
7. using measurements will be metric. By 2019, old road signs will begin being replaced on highways, and
8. by 2021, old road signs in the suburbs will begin being replaced
9. **Section IV:** All consumer items will be using metric within 2 years or else the company will be fined
10. 1,000 dollars for each nonmetric product manufactured. All companies that switch to the metric by within
11. the first 2 years of the bill being signed shall receive a 3% tax break for changing After December 31st
12. 2027, all companies who still manufacture in non metric measurements will be fined 2% of their entire
13. worth, for companies that make over 150,000 dollars, it will be 3%, and for companies who annually .
14. bring in over 250 million dollars will be fined 5%. This will go up one percent every year the 20.
15. company refuses to conform, the cap will be at 2047, when every year, after that, the
16. company must give a fifth of its annual revenue the government as a penalty.
17. **Section V:** Classes for the 4th grade and under shall immediately stop teaching of the
18. USC system, and for grades 5-9, it will be gradual, with full metric being taught in 3 years.
19. This will be funded completely by the government
20. **Section VI:** A new metric board shall be revived in order to assist with this conversion
21. **Section VII:** This process will be funded by taking up 5% of our total spending from our military for the
22. entire 10 year process
23. **Section VIII:** All bills opposing shall be nullified immediately when passed
