## **Permanent Residency & Immigration Act**

1. Be it enacted by this Student Congress here assembled:
2. **Section I:** All legal immigrants who have lawfully resided in the United States
3. for 15 or more years who have applied for, but have not been granted
4. permanent residency, are hereby declared permanent residents (green card
5. holders.)
6. **Section II:** Must be a legal temporary resident who has already applied to
7. qualify. Applicants must be up to date on all taxation and must be employed. If
8. applicant is unemployed, therefore unable to pay taxes, they must have
9. proper documentation allowing them not to do so. Any applicant with a
10. criminal record past a misdemeanor or civil infraction will not qualify.
11. **Section III:** All procedures regarding this bill will be carried out by United
12. States Citizenship and Immigration Services. Applicants will be responsible
13. for all general application fees. Processing will be handled by the
14. aforementioned organization.
15. **Section IV:** Any laws conflicting with this law are now null and void.
16. **Section V:** This legislation will be implemented on January 1, 2021.

### **A Bill to Ban Charter Schools**

1. Be it enacted by this Congress here assembled that:
2. **Section I:** All charter schools in the United States shall be banned.
3. **Section II:** A charter school shall be defined as a publicly funded independent school
4. established by teachers, parents, community groups, or corporations under the terms of a
5. charter with a local or national authority. Students currently enrolled in charter schools
6. will be given assistance by state governments, if needed, to relocate to a different school.
7. The ban will affect a charter school after their session ends for the school year, thereby
8. preventing any schools from closing in the middle of the school year.
9. **Section III:** This bill will be implemented on July 1st, 2020
10. **Section IV:** This bill shall be enforced by the U.S. Department of Education and the
11. Secretary of State in every state of the U.S.A.
12. **Section V:** All laws in conflict of this resolution will be declared null and void.

## Bill to Repair Roads

1. Be it enacted by this Congress here assembled that:
2. **Section I:** Michigan roads shall be repaired according to the terms specified in this bill.
3. **Section II:** Michigan roads shall be defined as any public road maintained and built
4. by the government of Michigan.
5. **Section III:** Upon the implementation of this bill, or any future circumstance which
6. warrants additional funds for the maintenance of Michigan roads, any and all
7. conditions of a road as defined above which inhibit smooth travel and/or pose a threat
8. to the safety of drivers and/or others shall be repaired. Such conditions may include
9. but are not limited to potholes, uneven road surfaces, and faded paint.
10. **Section IV:** This bill will be implemented from January 1, 2021 to January 1, 2026
11. and may be reinstated when additional funds repairs are necessary for a period of 6
12. months at a time.
13. **Section V:** The Michigan Department of Transportation is responsible for the
14. implementation of this bill. Funding for this bill will be provided through an increase
15. of 3 USD per gallon on the beer excise tax.
16. **Section VI:** All laws and portions of laws in conflict with this bill are hereby declared  
null and void.

### Bill to Require All Eligible American Citizens to Vote

1. Be it enacted by this Student Congress here assembled that:
2. **Section I:** All eligible voters in the United States of America be required to vote at all local,
3. state, and federal elections.
4. **Section II:** Every individual 18 years or older that qualifies as a citizen (by birth or
5. naturalization) of the United States of America shall be required to vote at every political
6. election they are capable of in their zip code. Election is to be defined as the selection of a
7. particular candidate or party to fill any corresponding position of political authority based on
8. whomsoever the majority of the votes fall in favor for. This includes voting on proposals or
9. political decisions. Eligible persons must vote in a designated office falling in their zip
10. code. Requirements exclude hospitalized persons in a facility that has required their absence
11. or citizens who have submitted a personal absence form which has been verified before
12. their leave explaining the situation for their absence. Personal absence forms are only
13. applicable to a citizen if they are not present in the vicinity of their zip code during the entire
14. election period.
15. **Section III:** The Department of Justice will be executing this bill along with any subsequent
16. responsibilities it may require. Any eligible voter found in violation of this bill will be subject
17. to a fine for 200 dollars for the first offence and an additional 50 dollars for any subsequent
18. offences until the 10th offence which will be followed by an additional 500 dollar fine and
19. confrontation by the local authority This bill will be funded by the aforementioned
20. department.
21. **Section IV:** All other laws conflicting with or pertaining to this law are now null and void.
22. **Section V:** This legislation will be implemented on December 1, 2019.

### **The Early Foreign Language Act**

1. Be it enacted by this Congress here assembled that:
2. **Section I:** All primary schools shall offer a foreign language
3. class to its students.
4. **Section II:** Under this act, all public primary schools will offer at least
5. one foreign language, of the school district's choice, to its students.
6. This language will be offered, for at least two hours per week; the
7. time can be split up to accommodate the school's current schedules,
8. **Section III:** The Department of Education will execute this bill along
9. with all other subsequent responsibilities. If the school district
10. complies with this act, they will receive a financial reimbursement
11. of 100,000 USD, yearly. Funding will be provided by the
12. aforementioned agency. In order to make these expenses, 5 percent of the US military
13. budget will be put towards the Department of Education.
14. **Section IV:** All other laws conflicting with or pertaining to this law
15. are now null and void.
16. **Section V:** This legislation will be implemented August 1, 2022.

## **A Bill To Abolish the US Senate**

1. Be it enacted by this Congress here assembled that:
2. **Section I:** The United States Senate shall be abolished over a gradual, moderated
3. period of 8 years
4. **Section II:** During the beginning of the 8 year period, the senate would slowly lose
5. authority over deciding US law
6. **Section III:** Senate elections for all 50 states shall all take place on election day of
7. 2020, which would be the last Senate elections to take place. After these elections, the
8. senators who will have won their elections will serve until January 2029
9. **Section IV:** The US House of Representatives shall be reformed into a
10. parliamentary government, with the the Speaker of the House becoming the Prime Minister of the
11. US, and having the House take in all the duties and responsibilities of the now abolished US
12. Senate
13. **Section V:** This transition of government will be overseen by the House of
14. Representatives, the Judicial Branch, and a new committee which shall be formed specifically
15. to oversee this transition and to ensure it happens peacefully and civilly
16. **Section VI:** This bill requires no funding
17. **Section VII:** The creation of the Senate in Article I of the constitution shall be removed
18. from the constitution
19. **Section VIII:** The 8 year period of the gradual removal of the Senate shall begin
20. immediately with the passing of this bill
