A Bill to Require Mental Health Screenings

1. Be it enacted by this congress here assembled:
2. Section I: All high school students shall be required to complete a mental health
3. screening that evaluates anxiety, depression, mood disorders, and eating disorders with
4. a qualified practicing physician once a year.
5. Section II: If a student demonstrates adverse mental health problems, a medically
6. reputable treatment plan must be implemented to improve the students' state of mind.
7. Section III: The cost of the exam and possible treatment will be at the expense of the
8. guardians of the child unless financial need is demonstrated, in which case the
9. Department of Health and Human Services will assume the expenses.
10. Section IV: The Department of Health and Human Services will be in charge of
11. implementing this bill. The expenses of this bill will be paid for by a 2% tax on gasoline.
12. Those in violation of this bill will be fined \$500 each year that they fail to
13. conform to the bill.
14. Section V: All laws in conflict with this bill are hereby declared null and void.
15. Section VI: This bill shall be implemented on January 1st, 2020.

Financial Literacy Bill

1. Be it enacted by this Congress here assembled that:
2. **Section I:** All public high schools in the United States require high school students to
3. pass a financial literacy class in order to graduate.
4. **Section II:** A financial literacy class shall be defined as a class which covers topics such
5. as saving, budgeting, mortgages, investing, loans, credit cards, and other important areas
6. related to financial literacy. The curriculum for this class shall be set by each state's
7. Department of Education.
8. **Section III:** This bill shall be enforced by the U.S. Department of Education and the
9. Secretary of State in every state of the U.S.
10. **Section IV:** This bill shall be enacted on August 1st, 2022.
11. **Section V:** All laws in conflict of this resolution will be declared null and void.

Bill to End Arms Sales to Saudi Arabia

1. Be it enacted by this Student Congress here Assembled:
2. **Section I:** All current and future sales of arms to the Kingdom of Saudi Arabia from the United
3. States shall be deemed illegal.
4. **Section II:** Arms shall be defined as defense articles, defense services, or related technical
5. data sold from the US Federal Government or US Arms Manufacturers to foreign nations.
6. All current and planned shipments of arms to Saudi Arabia, along with arms sales negotiations
7. between the federal government/US arms manufacturers and Saudi Arabia, shall be halted with
8. the implementation of this bill.
9. **Section III:** This bill is to be enforced by the Department of Defense and the Department
10. of State. The Department of Defense is to reject all Saudi Arabian requests for the sale of arms. 11. The
- Department of State is to reject all requests for all export licences to Saudi Arabia.
12. **Section IV:** This bill will override the US Conventional Arms Transfer policy.
13. **Section V:** All other laws or portions of laws conflicting with this law are now null and void.
14. **Section VI:** This legislation will be implemented on March 1st, 2020.

Bill to Require Deposit on all Beverage Containers

1. Be it enacted by this Congress here assembled that:
2. **Section I:** All beverage containers sold in the United States shall be required to have a
3. minimum five-cent returnable deposit charge.
4. **Section II:** Beverage containers shall be defined as any airtight metal, glass, or
5. plastic container under 1 gallon that contains a beverage for human consumption.
6. **Section III:** The Department of Commerce in each state shall be responsible for
7. implementing a beverage container deposit program. Any violation of this bill will result
8. In each state issuing a fine of \$200,000 for each offense committed by any company or
9. store.
10. **Section IV:** There is no funding needed to put this bill into effect. For unredeemed
11. deposits, 75 percent shall go to state environmental programs and 25 percent to state
12. retailers.
13. **Section V:** This bill will be implemented on December 1, 2020.
14. **Section VI:** All other laws and portions of laws found to be in conflict with the
15. provisions of this bill are hereby declared null and void.

A Bill To Establish A Confederacy of States

1. Be it enacted by this congress here assembled that
2. **Section I:** The United States shall convert to a system of a confederacy of states
3. with greater individual sovereignty for each state
4. **Section II:** This process shall happen over a gradual process of 10 years, with
5. government power slowly being relinquished and being replaced by the state
6. governments
7. **Section III:** The House Of Representatives would be abolished and the senate would
8. act as a delegation of states to only unite the country
9. **Section IV:** The president shall lose all its power except for militarily defending the
10. union and to act as a morale mascot unifying the states
11. **Section V:** The Supreme Court would only have the authority to defend basic civil
12. and human rights, with rare power to intervene between state affairs
13. **Section VI:** The federal government will only have the powers to print money and act
14. as a mediator between the states to prevent conflict
15. **Section VII:** This confederacy of states is in no way related to the Confederate
16. States of America during the civil war
17. **Section VIII:** This bill requires no funding
18. **Section IV:** The constitution will stay in place, but all mentions of the former
19. executive powers and of the House of Representatives will be removed from the
20. constitution and remodified to fit a system of state sovereignty and little federal power

Bill to Eliminate Daylight Savings Time

1. Be it enacted by this Congress here assembled that:
2. **Section I:** The United States will no longer participate in the use of Daylight Savings
3. Time.
4. **Section II:** Daylight Savings Time will be defined as time during which clocks are set
5. one hour or more ahead of standard time to provide more daylight at the end of the
6. working day during late spring, summer, and early fall. After the official starting date,
7. stated in Section III, any states not participating in the abolition of Daylight Savings Time
8. will have a 1% Federal Budget cut.
9. **Section III:** This bill will be implemented March 1st, 2019.
10. **Section IV:** The Department of Transportation and Department of Justice will be
11. responsible for the enforcement of this bill. Any necessary funding will come from a 0.5%
12. decrease in the defense budget.
13. **Section V:** All laws and portions of law in conflict with the provisions of this bill shall
14. hereby be considered null and void.
