

Bill to Ban Confederate Flag on Government-Owned Property

1. Be it enacted by this Congress here assembled that:
2. **Section I:** It is hereby illegal to display the Confederate flag on government-owned property.
3. **Section II:** The Confederate flag shall be defined as the battle flag used by the Army of Northern
4. Virginia during the Civil War, featuring a blue saltire trimmed with white, with 13 white stars,
on
5. a field of red. Government-owned property shall be defined as all property owned by the federal,
6. state, or local government, including but not limited to residential, commercial, and industrial
7. land. Displaying the flag includes placing or hanging the flag or images of the flag in a location
8. visible to the general public.
9. **Section III:** This bill will be enforced by the government agency which administers the
10. institutions in violation of this bill. For example, the Administrative Office for US Courts shall
11. enforce the bill for all US District Courts, and the Dept. of Education shall enforce the bill for all
12. public schools. All institutions found in violation of this bill will be fined as seen fit by the
13. agency enforcing the bill.
14. **Section IV:** This bill requires no funding.
15. **Section V:** All laws in conflict with this bill are hereby declared null and void.
16. **Section VI:** This bill will be implemented beginning January 1, 2021.

Bill to Implement Year-Round Schooling

1. Let it be enacted by this Congress assembled here that:
2. Section I: All Michigan public schools will operate on a year-round schedule.
3. Section II: Any public school in the state of Michigan will operate as a year-round
4. school. A year-round school has multiple longer breaks rather than a single extremely
5. long summer break. Instead of having one summer vacation, the schools will have
6. multiple medium sized breaks that are to be 2 - 3 weeks long along with 3 breaks will be
7. 4 weeks long. The number of days that the year-round school has will not be more than
8. 190 days and cannot be less than 180 days like any other year-round school.
9. Section III: This bill shall be enacted beginning in the 2020-2021 school year.
10. Section IV: Michigan's Board of Education should be responsible for administering this
11. bill. If a public school does not comply with this law, then they will be penalized by
12. cutting the school fundings in half.
13. Section V: Any laws conflicting with this law are hereby declared null and void.

Aerial Surveillance Justice Act

1. Be it enacted by this Student Congress here assembled:
2. **Section I:** All law enforcement agencies are hereby required to obtain a probable cause search
3. warrant before conducting aerial surveillance using a drone(s).
4. **Section II:** A drone is to be defined as any unmanned aircraft that can be guided remotely or
5. operate without human control beyond line of sight. Aerial surveillance is to be defined as the use
6. of a drone to monitor, examine, or otherwise analyze a person's or persons' body, property, or
7. other area which the person would reasonably be expected to consider as private by a law
8. enforcement officer for finding evidence of a crime.
9. **Section III:** This bill is to be enforced by the Department of Justice.
10. **A.** Any search conducted in violation of this bill would be deemed invalid, and any
11. evidence obtained in said search would be deemed inadmissible in a court of law.
12. **B.** All costs incurred by this bill will be paid by a .01% decrease in the military budget
13. **Section IV:** This legislation will be implemented on March 1st, 2020
14. **Section V:** All other laws or portions of laws conflicting with this law are now null and void,
15. excluding laws that govern when police are allowed to conduct a search without a search warrant

A Bill to Legalize LSD

Be it enacted by this congress here assembled:

Section I: LSD shall be legalized strictly for federal and national research purposes.

Section II: LSD shall be defined as Lysergic acid diethylamide, also known as acid, a hallucinogenic drug. Effects typically include altered thoughts, feelings, and awareness of one's surroundings. LSD is found in the ergot fungus that grows on rye and other grains.

Section III: The cost of the LSD will be at the expense of the research facilities to produce and conduct studies along with experiments using the chemical compound.

Section IV: The Department of Health and Human Services will be in charge of implementing this bill and enforcing it. The expenses of this bill will be paid for by a 2% tax on gasoline.

Violation of this bill is defined as the consumption of LSD being used outside of research purposes. Those in violation of this bill will be fined \$500.

Section V: All laws in conflict with this bill are hereby declared null and void.

Section VI: This bill shall be implemented on January 1st, 2020.

A Bill to Ban Cash Bail

1. Be it enacted by this congress here assembled:
2. **Section I:** Cash bail shall hereby be banned to determine whether an accused person is
3. detained prior to and during trial.
4. **Section II:** All instances in which cash bail would have previously been used, a statistical
5. risk assessment that accounts for the accused persons potential safety rush to the public,
6. reliability of reappearance, and past experiences with court will be used to determine
7. whether they will be released or not.
8. **Section III:** All accused people currently free or detained will be re-evaluated upon the
9. passing of this bill.
10. **Section IV:** The Department of Justice will oversee the implementation of this bill. This
11. bill will be funded by the funds previously allotted to the Department of Justice for
12. pre-trial expenses.
13. **Section V:** Any judges in violation of this bill will immediately removed from their
14. position with no opportunity of rehiring until one year has passed. If the judge is rehires
15. and acts in violation of the bill, they will be forbidden to act as a judge in the United
16. States of America.
17. **Section VI:** All laws in conflict with this bill are hereby declared null and void.
18. **Section VII:** This bill shall be implemented on January 1st, 2020

Bill to End Standardized Testing

1. Be it enacted by this Congress here assembled that:
2. **Section I:** All standardized tests will no longer be administered in any
3. public school.
4. **Section II:** Standardized testing will be defined as any test designed and
5. created by the state or any independent organization. Tests administered
6. by the school district, school, or classroom teacher are exempt from this
7. law.
8. **Section III:** This law will be implemented on July 1st, 2022, and will
9. apply to the "school year" starting in 2022.
10. **Section IV:** The Department of Education will be responsible for
11. implementing this bill. No funding will be required for this bill.
12. The penalty for non-compliance with this bill will result in a \$15,000
13. fine to the school district.
14. **Section V:** All laws or sections of laws violating this law are hereby
15. declared null and void.

Compulsory Voting Act

1. Be it enacted by this Congress here assembled that:
2. **Section I:** All U.S. citizens 18 years of age and above are hereby required to vote in state
3. and federal elections.
4. **Section II:** State elections shall be defined as elections to choose offices at the state level.
5. Federal elections shall be defined as elections to determine the country's President.
6. **Section III:** There shall be monetary consequences for failing to vote. The first failure to
7. vote will incur a \$50 fine on any individual who fails or refuses to vote. Any additional
8. penalties will incur a \$100 fine for each election that the individual fails to vote in.
9. **Section IV:** This bill shall be enforced by the Federal Election Commission and the
10. Secretary of State in every state of the U.S.
11. **Section V:** This bill shall be enacted on January 1st, 2024.
12. **Section VI:** All laws in conflict of this resolution will be declared null and void.

Bill to Raise the Driving Age to 18

1. Be it enacted by this Student Congress here assembled:
2. **Section I:** That the legal driving age in every state will be raised to 18 years old.
3. **Section II:** A) This bill would therefore make the age of 16 years and 9 months the legal
4. time to start Drivers Ed. B) To earn a driver's permit, you must now be between the age
5. of 16-18 years old. C) Any licence or permit that were valid previous to this bill are to
6. remain valid.
7. **Section III:** The state governments would be responsible for enforcing this bill. A
8. violation of this bill would result in a fine of \$500 or a sentence to jail for up to 6
9. months. Permits that were earned previous to the terms of this bill have to stay clean of
10. offence for a total of 6 months before being valid to use again.
11. **Section IV:** All conflicting legislation with this bill are hereby declared null and void.
12. **Section V:** This bill will be implemented as of January 1, 2021.
