

- Around the age of Dahmer had a minor surgery to correct his double hernia. This surgery was the start of his unending insecurities.
- His father got a new career opportunity, which resulted in the family to moving to Ohio.
- Dahmer lived a normal life, but as he got into his early teens, his insecurities grew, he withdrew himself from society, and became an unsocial and isolated teen.
- At the age of 14, Dahmer's parents divorced, which took a toll on Dahmer's psychological state. Around this time, he grew an interest in murder and necrophilia, so the events of his parents divorce deepened his sick interest.
- He grew an interest in dissecting dead animals in high school. This was also around the time he started to drink heavily.

Military Service

- Dahmer dropped out of Ohio University.
 Because of his drinking problem.
- His father suggested that he enlist into the army, agreeing to it, Dahmer was soon posted to Germany, December 1987.
 - The military then discharged him, again for his abuse of alcohol.

Legal Troubles

- Arrested twice in 1981 and 1982, for disorderly conduct due to his alcohol problem.
- He received a 1-year probationary sentence, and charged for sexaul assault and sexual exploitation in September 1986, for masturbating in front of 2 young boys.
- In May 1989, he received a 1-year prison sentence, a 5-year probationary sentence, and charged with sexual assault and sexual exploitation for molesting a 13-year Laotian boy, who is coincidentally the younger brother of one of Dahmer's future victims'- 14 year-old Konerak Sinthasomphone, whom he sexually assaulted and strangled to death.




Arrest Records


- Dahmer was arrested twice for disorderly conduct in 1981 and 1982.
- Dahmer was arrested twice for sexaul assualt and sexual exploitation, in September 1986 and September 1988.
- On July 22, 1991, Dahmer was arrested. On February 17,1992, Dahmer was found guilty of murdering 17 men in total, earning him 15 consecutive life terms (957 years) in prison.



Forensic Techniques

- The police was lead to all of Dahmer's crimes by a man, Tracy Edwards, who Dahmer attacked and threatened earlier that day. The man escaped, and lead the police to the crime scene.
- The police discovered a severed head, and other body parts in Dahmer's fridge. From there, they collected the blood splatters that was on the floor of the fridge for DNA tests.
- The police also found multiple, dismembered body parts belonging to his victims. Investigators used DNA samples to identify which body parts belonged to which, and who they were.
- The FBI also needed to fill some holes on who the victims were, and where they come from, so they traced Dahmer's trail around the United States, and even around the world.





Modus Operandi

- Dahmer would go to gay bars to to find victims, who were usually African American men that were traveling or close to becoming criminals, and convince them to come back to his apartment by bribing them with money.
- When he'd bring them back to his apartment, he would drug his victims by lacing their drinks with drugs, and then strangle them to death.
- He would then do whatever he wanted with the unconscious bodies and then dismember them. Sometimes he would experiment with his victims by drilling into their skulls while they were still alive, and inject them with muriatic acid to "preserve" them and see how long they'd survive.
- He would keep some of the body parts as trophies, take pictures of the bodies during the murdering process, and he would eat the flesh as well. He kept the leftover body parts in his freezer, fridge, and gallon-drums.




These are pictures of Jeffrey Dahmer's victims.
